Kampala, 6th July 2021 - Sports Club Villa hereby takes the opportunity to thank the fans for the unwavering support towards club in the just concluded football season.

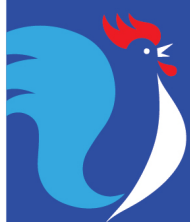
Uganda's most successful football club, SC VILLA, hereby publishes its ownership, governance and roadmap to Elections.

VILLA MEMBERS' TRUST (VMT)

1. At a meeting held on the 12th day of December 2019 by the known surviving founding persons of now Sports Club Villa (1982), formerly Nakivubo Villa (1979), Nakivubo Boys (1975) resolved to establish an Irrevocable Trust the Villa Members' Trust (VMT) as a corporate body with perpetual succession.
2. It was further resolved that the VILLA MEMBERS' TRUST (VMT) owns Sports Club Villa
3. On the 3rd July 2020 the **VILLA MEMBERS' TRUST** was incorporated in accordance with the Trustees Incorporation Act, CAP.165 (Certificate of Incorporation No. 1018)
4. On the 24th July 2020, Sports Club Villa applied to change Ownership to the **VILLA MEMBERS' TRUST (VMT)**

5. On the 12th September 2020, FUFA issued the Certificate of Ownership of Sports Club Villa to the **VILLA MEMBERS' TRUST (VMT)**
6. Since 12th September 2020, SC VILLA is owned by the VILLA MEMBERS' TRUST (VMT)
7. On 30th October 2020, the registration of the Members of the **VILLA MEMBERS' TRUST (VMT)** commenced at Sheraton Hotel-KAMPALA
8. The current members of the **VILLA MEMBERS' TRUST** are found at the link below;
